## Segmented Services

The **CEO Advisory Series** is an invitation-only program being offered to a select group of company leaders at major multinational businesses in China. This Advisory program includes a monthly regulatory newsletter as well as notifications about China-specific reports from institutions like Mercator and CSIS. The member can also attend up to 12 programs per year including:

- Specialized round table CEO peer-to-peer discussions\*
- Economic outlooks by leading economists
- Chinese CEO summits
- Global CEO roundtables
- US Consulate meeting facilitation
- Journalists/ Academicians viewpoints
- Policy updates from US Government officials

Fee: RMB40,000 per year (in addition to corporate membership fee) and invites the CEO/MD and 2 of their Staff members for the admission price.

The **Government Policy Support (GPS) Program** is intended for AmCham members who seek to stay informed of Chinese government policy and want to know how these policies will impact their businesses. The program will focus specifically on Chinese government policy across four focus groups: technology, manufacturing, healthcare, and financial services. GPS Program members will enjoy the following privileges:

- Quarterly briefings by industry specialists on relevant policy topics
- Quarterly reports on policy topics written by industry specialists
- Free seats on two AmCham Shanghai-led government delegations
- Priority for in-house meetings with government officials
- Access to the GPS Helpdesk for policy and industry related questions

Fee: RMB12,000 per year (in addition to corporate membership fee), will include one (1) member specific for the GPS series.
