What to Expect for Travelers Returning to China Guide

January 2021

The information contained herein is a compendium of travelers' experiences returning to China and should not be considered an official document. The processes described are for travelers on flights into Shanghai Pudong Airport.

Summary – What your return to China will involve

Here are the main steps of your return. Further details and suggestions can be found in the Appendices.

Currently all travelers back into China need to:

- Get a special one-time entry visa from an overseas Chinese Consulate.
- Submit a health declaration prior to departure and have the QR code handy – through email/print out/cell phone (which functions in China).
- Complete nucleic acid testing (NAT) within 48 days before boarding. Testing should be carried out in institutions designated or approved by Chinese embassies abroad (if already defined).
- Follow testing protocols defined by the local authorities upon arrival at Pudong Airport.
- Submit any doctor's health letters/documents for home quarantine exception during quarantine hotel assignment process.
- Be transferred to a quarantine hotel.
- If NAT is negative (no COVID-19 infection detected): remain in quarantine (home or hotel) until 14 days after arrival.
- If NAT is positive (COVID-19 infection detected): be transferred to specialist quarantine hospital unit for monitoring and treatment.

Before Traveling

Visa Application

- On receipt of your invitation letter from the Chinese Foreign Affairs Office (FAO), you will have to apply for your one-time entry visa.
- Each overseas Chinese Consulate has its own practices, so the process may vary depending on the consulate to which you apply.
- You can now book or confirm your flight. Most one-time entry visas are valid for 90 days.

Who to Tell?

At least five days before your flight departure date, email the names and passport numbers of the people travelling, their arrival flight date and flight number to:

1. Your Shanghai housing compound management office.
2. Your children's school(s) – they will need this information before accepting your child(ren) back onto their site.

Nucleic Acid Test (NAT) Report

- Complete nucleic acid testing (NAT) within 48 hours before boarding. Testing should be carried out in institutions designated or approved by Chinese embassies abroad (if already defined).
 - Please contact the nearest Chinese Consulate or Chinese Embassy for details.

Packing

- See the detailed packing list (**APPENDIX 4**) for essentials such as documentation, and recommendations for the journey and your stay in centralized (hotel) quarantine.

During Travel

- The travel situation and processes are constantly changing, so expect the unexpected.
- The food and drink service on the aircraft may be very basic. Bring some food and snacks to keep you going.
- Services may be restricted depending on the airline (i.e., children menus not available, no blankets or pillows).
- Keep your mask on as much as possible during the flight, both for your own protection and for the peace of mind of others.

Arrival at Shanghai Pudong Airport (Details in Appendix 6)

- On landing you may need to wait on the aircraft for up to 1-2 hours while the passengers are disembarked in groups, either by name or by seat location.
- Getting through the airport procedures may also take 3-4 hours; expect: queues, showing your health declaration QR code, temperature checks, form-filling and QR code scanning. A COVID test (NAT) will be taken from each traveler and sent for testing.
- Have all your documents ready and prepare to fill in multiple forms and declarations for each person. Keep your boarding passes: you will need proof of flights and seat numbers in coming days.
- Apply for home/central quarantine at the last “transportation” station.
- You will then go to wait for a special bus to transfer you to your assigned hotel where you will wait for your test results. The transit to that location may take a long time, anything up to 5 hours has been reported.
- It may seem confusing, but there are lots of people around to guide you through the stages.
- **SEE APPENDIX 5** to review detailed the detailed procedure of getting through Pudong Airport.

Arrival NAT & Quarantine (Details in Appendices 2 and 3)

Please note that many cities outside of Shanghai have recently begun to implement 21-day quarantines. Please check with your municipal health commission for more information.

As of January 7, 2021, Shanghai provides the following groupings for quarantine:

GROUP 1: Inbound travelers can complete 7 of their 14 days of quarantine at home. Traveler must request 7+7 quarantine at the airport. The first 7 days must still be done at designated observation hotel site and the remaining 7 days at home, as long as the individual's home/apartment has individual entrance and individual AC.

GROUP 2: Travelers meeting the following 3 conditions can apply for home quarantine in PVG upon arrival:

- a) Traveling with children under 16 years old, medical letter, or other (**APPENDIX 3**);
- b) Travelers have qualified home conditions;
- c) Travelers have negative COVID test results after arrival to PVG;



GROUP 3: Travelers with residences without individual entrance or individual AC must stay 14 days at a quarantine hotel.

Test results from the airport are normally communicated within 24 hours after arrival. All three groups will remain at a central quarantine hotel while waiting to receive test results. After receiving your negative test result at the central quarantine facility:

- If you are in GROUP 2, you will be transported to your home by local authorities to complete your 14-day quarantine at home;
- If you are in GROUP 1, you will spend seven days at your quarantine hotel, and will then be transported by local authorities to your home to complete the remaining seven days of quarantine;
- If you are in GROUP 3, you will remain for the full 14 days at the quarantine hotel.

For the quarantine hotels:

- There is no choice about which hotel you are put in. Families will be placed in the same hotel.
- Generally, it is strictly one person (over 14 years old) per room. Children under 14 years old may stay in a room with a parent.

If your test result is positive, or if you develop symptoms during your quarantine, you will be transferred to a COVID-19 specialist hospital unit. See **APPENDIX 2** for more details on the possible outcomes of your arrival NAT. If any passenger tests positive and is a close contact to you on the plane (+/- 3 rows of your seating location), you may need to stay/return to a quarantine hotel for the duration of your quarantine period regardless of home qualification.

Release and QR Code

- If you do not develop any COVID-19 symptoms during your quarantine period, when the 14 days are finished, you will receive a release certificate. You may be subject to complete a final NAT before your release certificate is issued.
- For those arriving after July 27 and under the new 7 days at hotel plus 7 days at home quarantine, a final NAT test is required before release.
- For those staying at the central quarantine hotel, upon completion of the 14 days period, you can then arrange your transportation and go home.
- Once you have your release certificate, you should download the Shanghai Health QR Code which will enable you to move freely around the city. Details on how to do that are in **APPENDIX 6**.

Appendix 1 – Preparing for your journey

Throughout the journey you will encounter staff in hazmat protective clothing, long waits, repeated form filling, constant temperature checks, and a lack of usual facilities such as restaurants, shops, inflight food service, etc. You may experience occasions of confusing or contradictory instructions, or a general lack of information. Try to remain patient and prepare your family members for what to expect. Stay hydrated, have snacks to keep you going, and bring things to keep you entertained as you work your way through the process.

Packing and preparation

- See **APPENDIX 4** for a detailed packing lists for essentials, hand luggage and check-in luggage.
- Pack as lightly as possible and use bags you can wheel.
- Pack bags for individuals as you will be taken to separate rooms on arrival at the quarantine hotel.
- Download computer games, e-books, audio books, films and TV shows.
- Download and set-up Apps for use in China, e.g. for food delivery.
- Set up WeChat groups with your family and fellow travelers.
- Explain to your children what will be happening and what to expect.
- Learn to use a thermometer (in degrees Celsius). Purchasing an electronic thermometer for each person in your household 14 years or older is recommended.
- It is important that everyone have a QR scanner app (is included in WeChat/Alipay) loaded on their phone. You are asked to scan things along the trip.
- If you are new to China, ensure to bring some cash and a valid credit card (Master or VISA)

Clothing for the journey

If you're travelling through the summer months, some areas may be uncomfortably hot and humid due the restricted use of air conditioning. Dress in several layers of light, comfortable clothing. You are also likely to be waiting in queues, so comfortable shoes are essential. One moderately warm layer, or light scarf might be useful.

Tip: don't over pack. Limit your hand luggage and use small cases with wheels or back packs. It's likely to be several days of queuing and moving from place to place, so large amounts of hand luggage to keep track of and move will be inconvenient. This includes your check-in luggage – don't pack more bags than you can wheel.

At your departure airport

Contact your departure airport for any specific processes or requirements for flights departing for Shanghai.

On the flight

Food and drink service on the aircraft may be limited to a very basic provision, or nothing at all. See **APPENDIX 4** for what to bring in your hand luggage. Flight attendants may well be wearing hazmat protective clothing; it might be worth explaining this to young children as it can be a bit unsettling.

Keep your mask on as much as possible during the flight, both for your own protection and for the peace of mind of others. You will probably have your temperature tested and recorded repeatedly throughout the flight.

You are required to declare if you have any symptoms of fever, cough, headache, sore throat, etc. Also, if you have taken any fever control medication such as paracetamol or ibuprofen, be honest.

Appendix 2 – The Nucleic Acid Test (NAT)

You will have a NAT sample taken on arrival at Pudong airport. If you have any COVID related symptoms you will be immediately transferred to a hospital. If you do not have symptoms you will proceed through the entire process until you receive the actual results (about 24 hours later).

The NAT sample taking is a two nostrils and/or throat swabs and takes a few minutes. Additionally, you may be requested to take a blood test.

IF your result is negative (no infection detected). You will follow the process of 1 of 3 groups defined in **APPENDIX 3.**

IF your result is negative but someone you've been in close contact with tests positive.

- Your status will be same as if you tested negative, but you may find you are subject to closer monitoring and additional testing. Home quarantine will no longer be possible even if your home qualifies.

IF your result is positive or you have COVID symptoms upon arrival.

- You will be isolated from other travelers, including your family, and taken to a Shanghai hospital where you will stay under observation and be treated for any symptoms that develop.
- This is regardless of previous negative test results, or whether you have symptoms. Although false positive results do happen, you will be treated as though you have the virus even if you are asymptomatic.
- If you test positive and you are a parent caring for a child, then the child must stay with the other parent, and neither the other parent nor child will be allowed to accompany you to the hospital.
- If you are travelling alone with a child, a guardian will be assigned to stay with your child, or in previous cases, parents have been able to nominate someone to come and take care of the child in their quarantine hotel.

Children with a positive test result.

- The NAT positive result process applies also to babies and children of whatever age – they will be isolated from their family and taken by medical staff to hospital. This very rarely happens but it is a possibility.
- Exchange contact details (WeChat, mobile number) with the medical staff taking your child. Give them all their documentation, including any medical information such as allergies.
- Although inevitably distressing, reports from when this has happened are that children are very well cared for in good medical facilities and parents are kept in touch with them and the people caring

for them. However, it is important to understand that it is not possible for anyone other than the medical staff to accompany them to hospital.

Appendix 3 – 14 Day Quarantine scenarios

Group 1: '7+7' quarantine protocol in Shanghai

From July 27, conditional '7 days centralized + 7 days at home' quarantine measures have been implemented for inbound travelers in Shanghai:

- People whose destination is Shanghai are eligible for the '7+7' mode if they have a fixed place of residence in Shanghai, and meet the conditions of home quarantine for health observation (that is, one person per one household or one family per one household, or the co-resident promises to stay at home together).
- For the first 7 days, the applicant must stay at the centralized hotel for the quarantine.
- If applying for home quarantine, the applicant will have a nucleic acid test on the 5th day of the centralized quarantine. If the test result is negative, on the 8th day, each district will arrange a special vehicle to transfer applicants from the centralized quarantine place to the residence place, and implement a 7-day home quarantine.
- Before the end of home quarantine, another sample of all the people in the same household will be taken for nucleic acid testing. If all are negative, the quarantine measures will be lifted after 7 days of home isolation.
- If one does not want to take home quarantine or do not have the conditions for home isolation, a 14-day centralized quarantine will be implemented at the assigned place.

Group 2: Home Quarantine

Currently quarantine in your own home is only allowed for:

- Children under 16 years old returning from overseas alone.
- Pregnant and postpartum woman.
- People aged above 65 years old.
- People returning from overseas, where there are children under 16 years or elderly people (over 65 years) to care for at home; or children or the elderly that are returning with that person.
- People suffering from a serious disease, e.g. coronary heart disease, etc.
- People with disabilities.
- People with a medical letter.

The decision is reliant upon your home ventilation system. If you live in an apartment with air vents that are shared with neighboring apartments, you will not be allowed to home quarantine, regardless of your condition.

The suggestion is to ask your doctor to provide you a medical history report and have the report translated to Chinese, as it may help you qualify for home quarantine application later based on the current practice.

If you are eligible for quarantine at home, you will be tested a 2nd time on day 12 or 13 at home. It costs RMB 120 per test and you can pay either by AliPay or Wechat.

Group 3: Central Hotel Quarantine

For those without a home with independent entrance and independent ventilation system as well as new expatriates to China, you and your family will be in a quarantine hotel for 14 days. Here are some things to expect and ideas to make your stay as bearable as possible.

- The quarantine hotels have been selected by the Shanghai local health authority. There is no choice about which hotel you are put in, but they will keep families in the same hotel.
- Generally, it's strictly one adult (over 14 years old) per room.
- You can try asking for older children to be put in a room together, or with a parent.
- Ask to be put in adjacent or nearby rooms, e.g. across the hallway. Make your requests politely and persistently but be prepared to accept the allocation of rooms you're given.
- Children 14 years old and under stay in a room with a parent. If you have more than one child, the children can either stay with one parent or can be divided between both parents.

Your Hotel Stay

- Most hotel staff speak only limited English, so be patient when explaining your needs. Having a translation App on your phone will be very useful.
- On arrival, explain any special health needs such as food allergies to the reception staff. Show them the medical statement (in Chinese).
- You are not allowed to leave your room at all during the 14 days. If you need anything, you will be able to call the hotel reception and ask for help. You may/will be asked to sign a document stating that you will abide by the regulations.
- During Checking-in, the medical staff may ask you to pay upfront using Wechat or Alipay. If you can't then tell them that you will pay using your card during checkout. Most overseas credit cards seem to work.
- Contacting the food service and reception during the day can sometimes be difficult. Instructions and contact numbers may not be clear. Check with the reception at the time of registration for a list of primary and alternate contact numbers.
- Water should be available to purchase at the hotel. Ask for bottled water purchase options at the time of registration. Food service will contact the room and deliver water. WeChat payment is required at the time of delivery. Western meals may be available depending on assigned quarantine hotel.

- You can also order basic necessities (Water, Paper towels, Toiletries) online and they will deliver it for you. Paypal – your source of money when you (if you are new to China) don't have WeChat Pay or AliPay set up. The following online grocery website for consideration where Paypal works. <http://www.timesgrocery.cn/>

Health Checks

- You'll be given a thermometer and asked to check your temperature morning and afternoon. You will be called/visited twice a day and asked for the results and whether you feel any symptoms of illness.
- Explain this to any older children who will be alone and show them how to take their temperature and read the thermometer.
- All the thermometers are in degrees Celsius and you need to report the results in Celsius.
- Small digital thermometers are easier to use, so if you bring one per person it will make the daily temperature checks a bit easier.
- Usual under-the-tongue or surface body temperature is between 36.0 and 37.2 degrees Celsius (96.8 – 99.0 degrees Fahrenheit). Anything above 37.2 degree Celsius will be considered a fever.

Food and Drink

- Breakfast, lunch and dinner trays will be brought to you each day. Generally, the food is only Chinese and there is no/limited choice of menu. Some hotels might provide simple set western food option. Generally, no other food or drinks will be provided by the hotel. Occasionally, they may call the room and ask if food is needed. Alcohol and tobacco are not allowed for deliveries. Bottled water may not be provided. Most hotels will provide a small kettle in the room, or you could bring a water filter. Although not ideal, for the period of your stay, tap water is unlikely to cause you any harm and is more of an inconvenience than a health risk.
- At some hotels, once per day food deliveries are allowed. You can use services like Sherepas or Epermarket from your phone to order in pre-packed food and drinks. However, the recent experience is that hotels do not allow fresh food deliveries due to the hot weather as it might impact the food quality. Only dry/packed/canned food deliveries are allowed once per day.
- Food allergies – on arrival, show the staff your medical declaration (in Chinese) and explain what you need, but be prepared that reliable provision for allergies is far from certain.

Hotel Services

- Service provision can vary from hotel to hotel, so this is a guideline only based on a range of previous experiences.
- Bedding, towels and toilet rolls are provided. If you need fresh supplies, call reception and ask.

- The usual hotel services of room cleaning, linen changes, toiletries (shampoo, soap), mini-bar, clothes laundry will not be available. Bring your own toiletries for 14 days, and a few spare toilet rolls (just in case!).
- The air conditioning has been operational based on reports from recent travelers. A small fan might be a good idea.
- TV is only Chinese, although some international channels like CNN, Discovery Asia, NatGeo may be available.
- Internet connection should be OK.

Release from Quarantine

- When your 14 days are complete without signs of COVID-19 you will be issued with a health certificate. Keep this as proof of quarantine release.
- Sometimes a further NAT will be conducted before leaving depending on policies of the local health authorities at the time.
- On your release day, you can arrange for transportation to take you home.
- You are now free to move about the city and return to work and school as normal. You will need the Shanghai Health QR Code for some places.

Appendix 4 - Packing List

Essentials

For each traveler you will need the following:

- Passport with Residence visa.
- One-time entry visa.
- Printed flight itinerary or ticket.
- Printed boarding card.
- COVID-19 NAT result document if any.
- Your destination home address in Chinese language.
- Face masks – at least 3/person – including for children.
- Regular medication for 3 weeks – in original packaging.
- Medical declarations (in English and Chinese language if possible), e.g. allergies, other relevant medical conditions.

Recommended in hand (carry on) luggage

- Black ball point pens for filling in forms.
- Disinfectant hand sanitizer or wipes.
- Reusable water bottle – to fill up from drinking fountains, etc.
- Phone with Chinese SIM card – including for children.
- iPad, Kindle, etc.
- Power banks for phones, iPads, etc.
- Headphones.
- Light, dry snacks, e.g. cereal bars, nuts, dried fruit, cookies or crackers, candy, etc. Avoid things that will melt (e.g. chocolate), or deteriorate (e.g. fruit, fresh foods).
- Neck support pillow.
- Small, light-weight games and toys to keep younger children occupied en route, e.g. cards, soft toys.
- Lightweight folding 'umbrella'-style buggy, backpack or papoose for carrying babies or young children that you can keep with you in the airports.
- For babies: nappies (diapers), cleaning wipes and disposable bags for at least 4 days.

Recommended in check-in luggage

When packing remember that from the point you reach the quarantine hotel you will be separated into your own rooms, so pack bags for individuals for 14 days.

- Medicine – both prescription and over-the-counter basic medications.

- EpiPens if needed.
- Digital thermometers (1/person).
- Small first aid kit.
- Disposable face masks (5-10/person)
- Toiletries for 14 days, including shampoo, shower gel/bath foam, soap, 1 or 2 spare toilet rolls.
- Baby or young childcare items (diapers, wipes, rash cream, formula milk, etc.).
- Comfortable light clothes – you will have to wash your own clothes, so pack items that will wash and dry easily.
- Flip flops or bedroom slippers.
- Hand-washing laundry liquid.
- Water bottle to keep supply of cooled, boiled water.
- Instant coffee, tea, milk powder.
- Snacks as treats: cereal bars, dried fruits, nuts, cookies, crackers, candy, etc.
- Books, or download e-books and audiobooks.
- Laptop, iPad, etc.
- HDMI cable to watch movies on your laptop via TV screen.
- Chinese electrical socket adaptors, multiplugs, extension cord.
- Mini speakers.
- Exercise equipment, e.g. yoga mat, skipping rope, resistance bands.
- Kids electronic devices and toys, e.g. iPad, Nintendo Switch, small balls, Lego, drawing pens and paper, juggling balls, jigsaw puzzles, etc.
- Small fan – air conditioning may not be working.
- Filter water bottle or small kettle.
- Small Fan.
- Towel.
- Light-weight cutlery.

Appendix 5 – How to Apply for Required Travel QR Codes

You will be expected to complete three Codes/Apps throughout the process:

- **Health QR Code** – Before Departure
- **Transportation Hub Code** – After Baggage Claim
- **Hotel Registration Code** – At Bus/Hotel Check-In Counter

Before Departure

Complete **Health QR Code Process** via scanning a QR Code at the airport or via the URL link (<http://health.customsapp.com/home/pages/index/index.html>) preferably at the departure gate prior to boarding. If you use the URL, save this URL both in your favorites on your laptop as well as a link on an email / page on your cell phone. It will expedite the entry of the data when you actually do it. You may also scan (via WeChat) at the departure gate.

The **QR code is only good for 24 hours**, so fill out the forms shortly before boarding time, the Health QR code may be required for boarding. If you fill it out too soon it will

be invalid when you arrive in Shanghai and you have to fill it out again. **(Note: If your trip is longer than 24 hours, you shall require filling it out again.)**

Complete the form on your laptop may be easier than on your mobile device, but both are possible. One person can generate all the QR codes required for a family – adults included, please use the same reference China phone number, the codes can be “view(ed)” as a collective list. Screen shots work very well, need to show these 3-4 times throughout the process including departure and arrival.

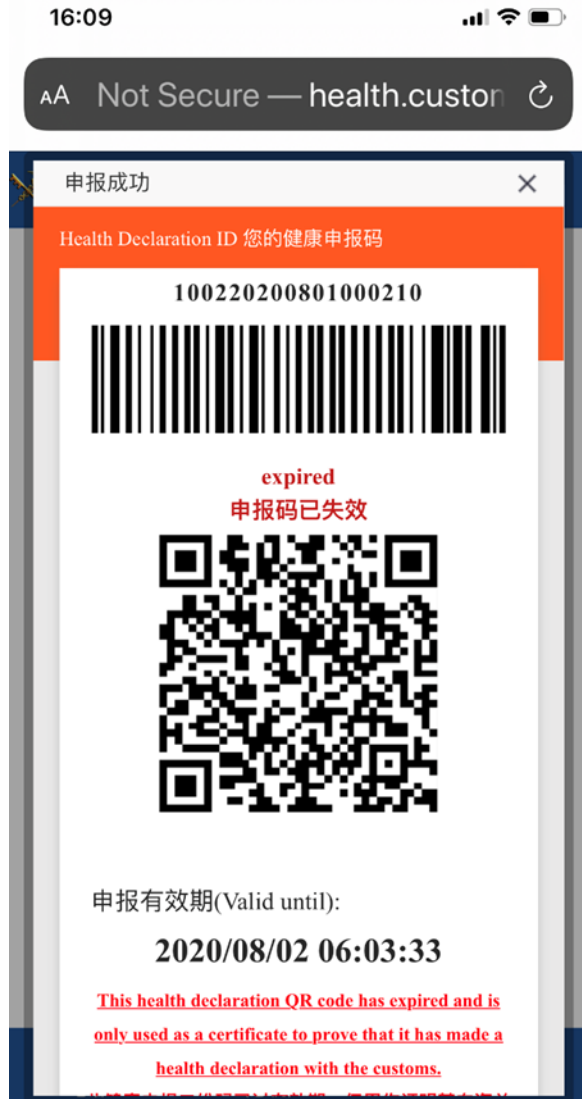

On the Plane

Pillows and blankets may be provided. Temperature in the cabin of the plane may vary throughout the flight and it can be quite cold at certain times. Bring a light jacket on wear long pants to help stay warm. In Incheon you will be given the “Yellow” arrival / departure card. Use the time to fill it in between Incheon and Shanghai. Try to go to

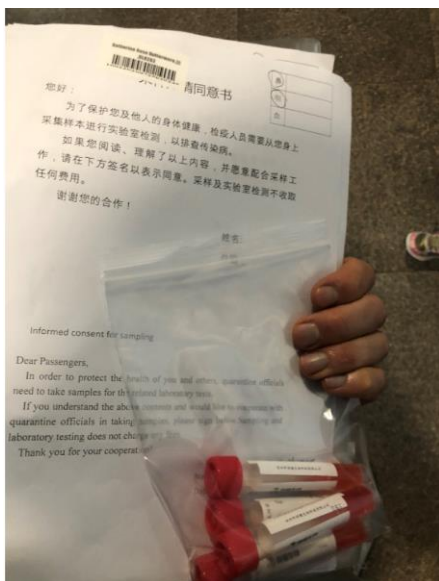
the bathroom before landing as you may need to stay in your seat for a while after landing at PVG. Additionally, make sure your mobile phone is charged.

After Arrival

Step 1: COVID Test Sample Collection

You will deboard and proceed through Temp scan and need to fill out a consent form for COVID testing. You will all sit at a desk to fill in the forms. Will need to show Health QR code again here (**Last chance to fill in Health Declaration again if it has expired**).

You will then proceed to a desk where you will show the consent and need to show each passport and Health QR code where a bar code will be printed and put onto a vial for sample collection. **Note! - If you have children and want to try to request a throat test only, recommend requesting this at the time that the forms are handed out, once you get to the actual testing location, the 2-nostril test is already checked (top box), and they simply execute per the instructions on the form.**



With test tube prep and form printing you carry the paperwork and tubes downstairs (there are only stairs - no elevator or escalator to get to the lower level.) Carrying hand

luggage with younger children can be a challenge. Proceed into a mobile trailer unit which is connected to the main building where the testing will be done.

Test could be 2 nostrils (and sometimes throat). NOTE: You can show the power point slides embedded below to the officer taking the sample, that will help the working staff know that you understand the procedure and will cooperate. If a good sample is taken at the first attempt, the officer may choose not to take other samples, but expect to have 2 nostrils tested.

When completed re-enter the building. There is a bathroom at this point if you need to stop. There is an escalator to take you back up to the main level.

Once you finish testing and another temp scan will move quickly through passport control and then on to baggage collection. Process is as what you would expect. Bags are already offloaded and waiting, and you can load them on to trolleys. Plan on having your bags X-rayed.

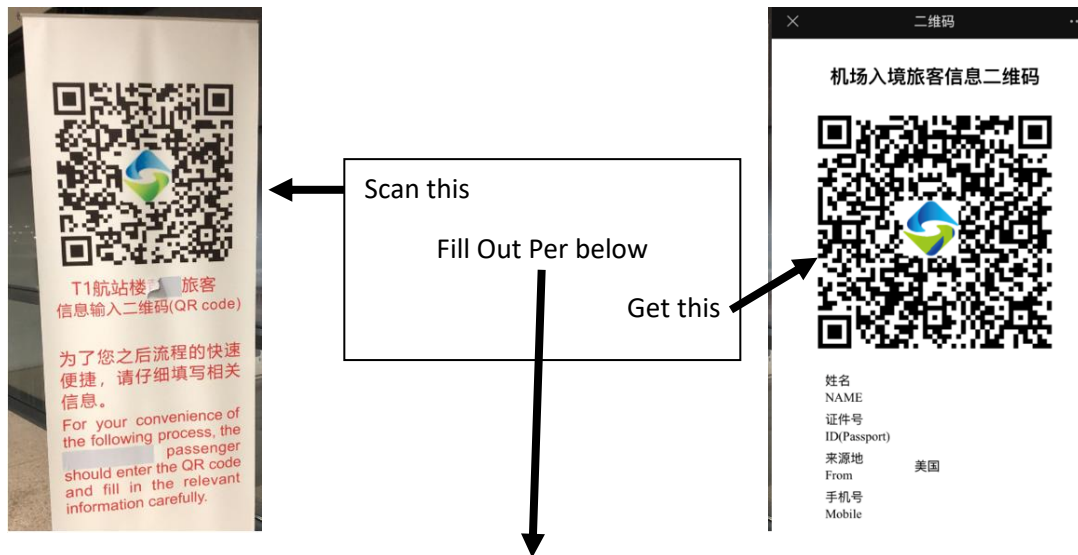
When you depart baggage claim (normally where there are 500 people waiting with signs), there will be people directing you either to the left (transfers to other cities) or to the right (Shanghai arrivals). For Shanghai arrivals, follow the hallway / signs on the floor, and take the elevator (there are 2) up 1 level. You will now be in the bridgeway that connects Terminal 1 and Terminal 2 (where the maglev train is). You will now need to scan a new bar code.

Step 2: Fill out Transportation Hub Code (Airport Arrival Passenger Information)

Right after getting off the elevators you will be stopped in the hallway. There you must fill out the **Transportation Hub QR Code** (Please find and scan the QR code on the tall white banners – see the sample picture as below) for each family member before entering transportation hall. This part of the process has been reported by other travelers to take time. Expect delays and confusion. Recommend that 1 person does for each traveler in your family as once completed it will generate a new QR code which you need to register for quarantine.

There will be one section where scroll down options were **only in Chinese** – after “Destination Area” (where you scroll and select “Pudong”): then there is a request for: “**Destination Province City & District**” – where you scroll down to select [**Shanghai in Chinese, which is the 10th option on the list**] and then further to the right, scroll down to select **Your Residence District** [e.g. **Pudong 浦东新区 in Chinese, which is the 12th option on the list or Jing'an 静安区; Xuhui 徐汇区; Huangpu 黄浦区**]

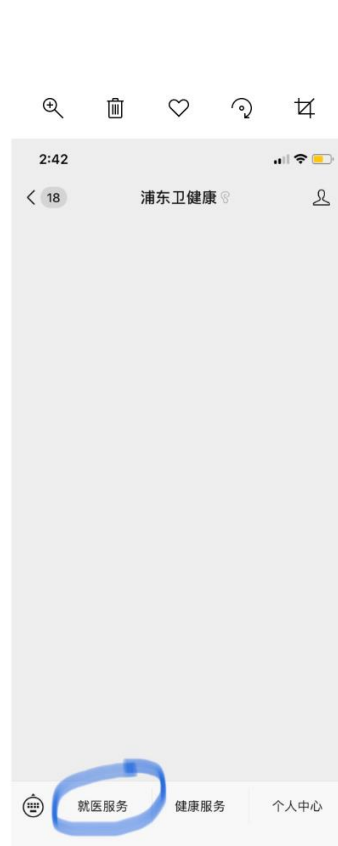

After clicking “done” and submitting, take screen shots (4 pages of screen shots required given the length of the form – similar to the images above) as you will need to show these at the hotel. Then click on “Rewrite” to start another form for each additional member of the family (taking screen shots after completing for each family member)

If for whatever reason you managed to not do this while at the airport and waiting for the bus, there will be an opportunity to scan a QR code while riding to your hotel and complete then. However, I would recommend using your wait time at the airport to complete the mini-program hotel registration.

Step 5: Transfer to Quarantine Zone for Central Quarantine or Quarantine Zone for Home Quarantine (Hotel # vary based on different residence district)

After filling out the mini-program and waiting for the bus, you will eventually be released to transfer to the government observation point from the transport desk area to the downstairs bus parking lot.

You can use baggage carts all the way to the bus. Getting down the elevator to get on the bus wasn't difficult. Some areas of the parking lot are uneven so be careful pushing overloaded luggage trolleys.

Since multiple families may be boarding at the same time, you may experience another delay here.



Suggested questions to clarify at time of check-in to hotel:

- Date & time of check-out
- Meal Plan – Options and costs
- Ability for deliveries to be made from delivery companies as well as drivers
- Confirm WiFi name and password, if any

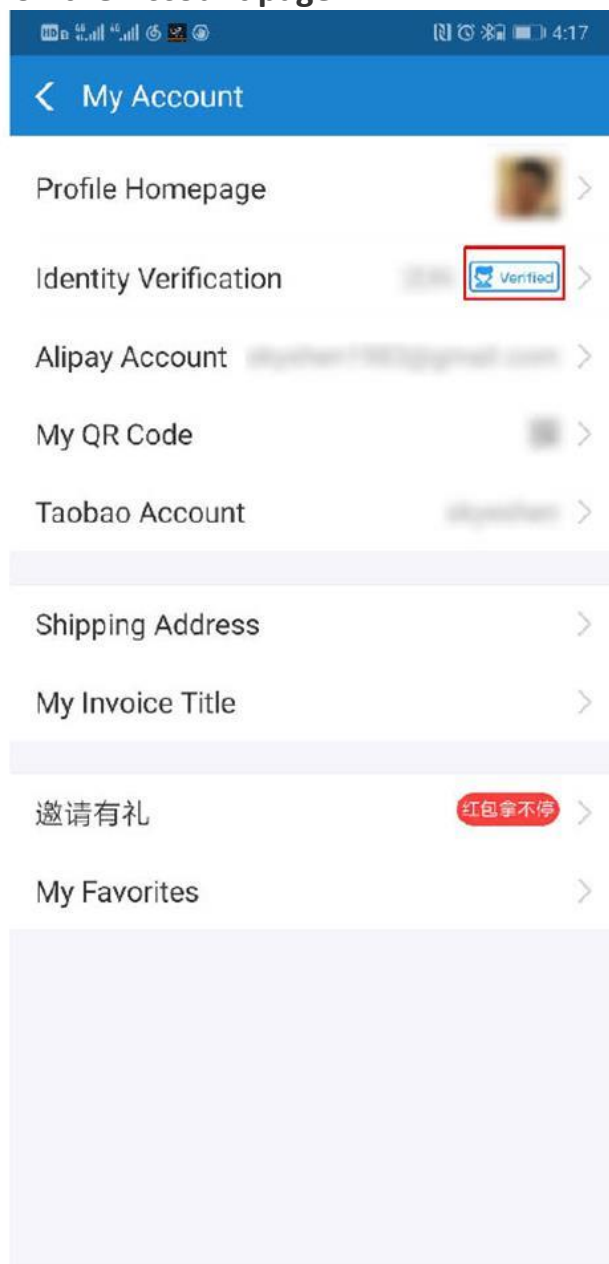
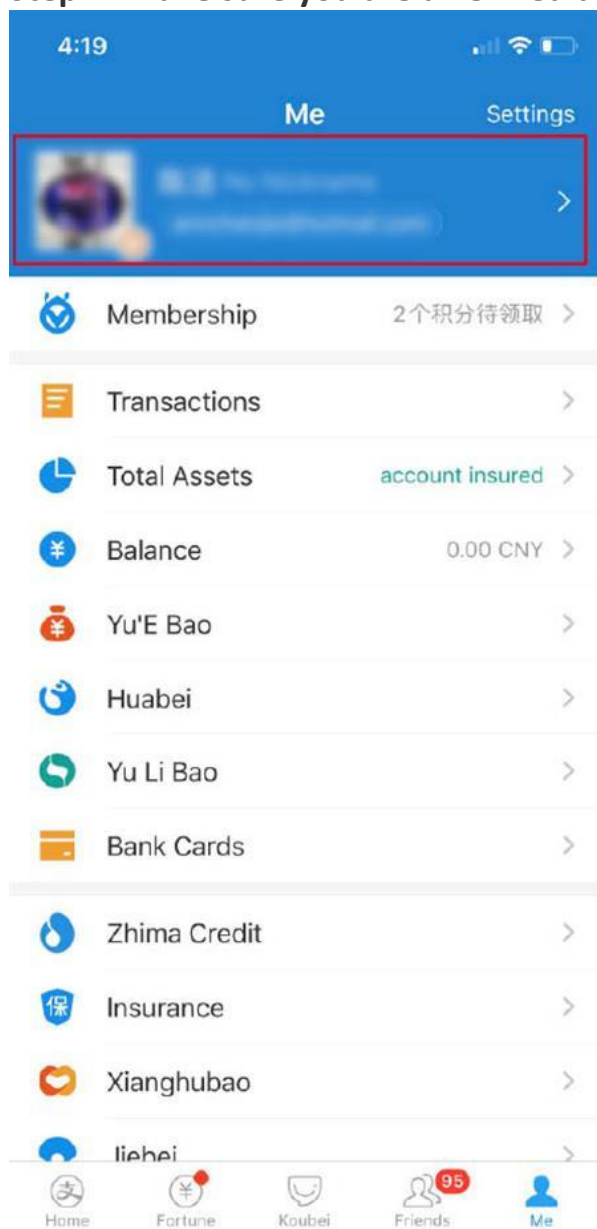
Appendix 6 –How to Apply for Shanghai Health QR Code Through Alipay

- Everyone over the age of about 10 years old needs the QR code to visit schools, offices, doctor's clinics, housing compounds, some restaurants and shops in Shanghai.

- You will only need this once you have been released from quarantine and received your quarantine exit certificate.

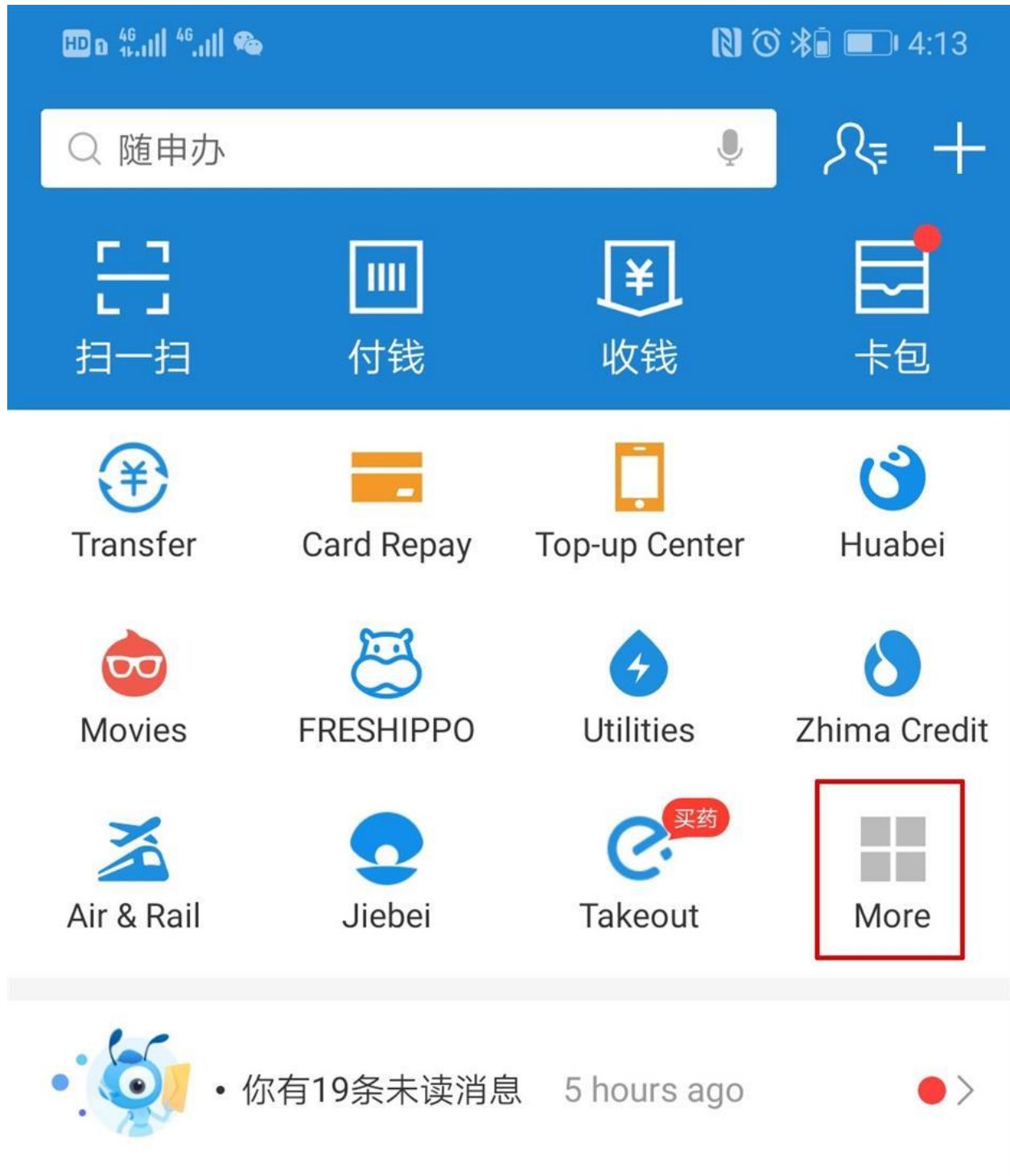

Observation point / Quarantine Hotel:

Upon arrival to the hotel you will need to fill more Chinese forms to fill out and you may still experience delays. Please have your phone translator ready to facilitate form filling.

NOTE: They will hold your passports from the transfer desk until the hotel check-in, you will get your passports back at the hotel lobby when you fill the forms.

From there you will be allowed into hotel room. AC should be functional. Amenities including towels, toiletries, water, etc maybe be limited. Plan accordingly.

If your test results come back negative, the hotel desk will call and inform you. Departure will be arranged by the hotel and specific timing will be given to you.
